## Incident Report

On the above date and time, Sgt. Burke, Ptl. Calicchio and myself responded to the above listed address in regards to a welfare check. Police Telecommunications related that a third party caller, later identified as Kenzo Vazquez, related that two subjects, later identified as Stephanie Starr, and Anthony Judice, were at the above listed address together. Kenzo related he was facetimeing with Stephanie, when Anthony took the phone out of her hand and disconnected it. Kenzo related both parties were intoxicated, and [REDACTED]

[REDACTED] Kenzo related he wanted a welfare check of Stephanie.

When units arrived on scene, we were met by Anthony, and his brother Rocco Giannotti. Anthony related he and his girlfriend got into a verbal argument over her going out with her cousin, who she has been known to get heavily intoxicated with and commit bouts of infidelity because of the intoxication. Anthony related he confronted Stephanie about not going out with her cousin anymore, and not to talk to her on the phone while at his house. Anthony related the cousin is a bad influence, and Stephanie is easily persuaded by the cousin. Anthony related at no point did the argument become physical, and Stephanie left the scene prior to police arrival. Anthony related he was uncertain if she left on foot or in her vehicle, but he did related she may have gone to Wawa to "cool off".

Ptl. Calicchio made contact with Rocco who related he overheard heard Anthony and Stephanie arguing, and he just wanted to make sure everything was okay. Rocco related at no point did the argument become physical, and remained only verbal in nature. Rocco also related Stephanie left the scene prior to officer's arrival, and he was uncertain if she drove her vehicle or left on foot.

While officer's were speaking with the two subjects on scene, officer's observed a silver sedan driving towards the residence on Sandstone Ct. Rocco related to Ptl. Calicchio, that the vehicle driving was possibly Stephanie's. Ptl. Calicchio and I started walking towards the vehicle's direction, when the vehicle stopped on the side of the street and parked. As officer's approached the actively running vehicle, bearing NJ Registration S31UDF, it was confirmed Stephanie was the driver. Stephanie was in the driver's seat as officer's approached. Stephanie rolled her driver side window down, and a strong alcohol odor was emanating from the vehicle's compartment. Stephanie was not forthcoming with what had happened prior to police arrival, in regards to the incident. Stephanie was confrontational with officer's and refused to follow instructions. Stephanie was asked to shut off her vehicle and step out in order to perform Field Sobriety Tests. Stephanie remained confrontational with officer's and it required multiple attempts to explain the situation to her. Stephanie was very irrational and visibly impaired. Stephanie's pupils were largely dilated, and she had a strong odor of alcohol emanating from her breathe.

Sgt. Burke advised Stephanie he would be performing HGN; refer to his supplemental report.

Stephanie refused to perform any further Field Sobriety Tests, and reiterated "get me my lawyer". After totaling the observations, it was in my opinion that Stephanie was operating a motor vehicle while under the influence of alcohol and was placed under arrest for DWI. She was searched incident to arrest, handcuffed (double locked), and seat belted in the rear of car #83, which was visually and physically inspected before and after transport. The MVR for car #83 was activated at the time of transport, as well as Ptl. Calicchio's BWC was activated throughout transport. During the search for intoxicants of the vehicle, four (4) bottles of Jim Beam Whiskey shooters were found within reach of the driver side compartment. Two (2) of the bottles

were opened, with one (1) being completely empty, and the other more than half empty (see attached photos). In accordance with John's law, the vehicle Stephanie was operating was impounded for 12 hours. Priced Rite Towing Service took possession of the vehicle and a tow report was completed for same.

At headquarters, Stephanie was searched and placed into cell #2. Cell #2 was visually and physically inspected before and after Stephanie's release. The cell was secured using the master lock to cell #2 and Ptl. Calicchio maintained possession of the key for the duration of processing.

Stephanie was mirandized and refused to sign same. She was read implied consent and when asked if she would submit a sample of her breath to determine the content of alcohol in her blood, she replied "If I say No, will I go to county?". Stephanie was then read the implied consent additional instructions and asked if she would submit samples of her breath to determine the content of alcohol in her blood, and she continued to state "No".

Face to face contact was maintained for the entire twenty-two (22) minutes with the departmental BWC activated. All electronics were removed from the room, and Ptl. Calicchio operated the Alco Test Unit. Stephanie refused to provide breath samples after the twenty-two (22) minute observation period.

Stephanie was issued motor vehicle summons for DWI (NJSA 39:4-50), Refusal to Submit to Breath Testing (NJSA 39:4-50.2), Reckless Driving (NJSA 39:4-96), Careless Driving (NJSA 39:4-97), and Open/Unsealed Container of Alcohol in Vehicle (NJSA 39:4-51B).

Rocco Giannotti, was explained the Potential Liability Form and signed same taking custody of Stephanie. Rocco was provided a copy of the Potential Liability Form. Rocco did not have a valid Driver's License on him to attach to the Potential Liability Form. Stephanie was negative NCIC/SCIC/ATS/ACS/NJWPS at the time of her arrest.

Officer's body worn cameras were utilized in accordance with department policy for the duration of the incident. The BWC footage was properly tagged for future discovery. NFA.
