Details of Incident (Indicate Means of Identification)							
<p>On 03/13/2023, I reported to Burberry located in the Mall at Short Hills on a report a theft that just occurred. Audrey Alexandre, Manager of Burberry, immediately notified Mall Security that three individuals who just left the store had stolen a purse. Alexandre stated two females and a male entered the store approximately 1842 hours and proceeded towards the rear of the store. One female dressed in a tan jacket with maroon scrubs, later identified as Diamond Burban, was then seen opening a stock drawer, removing a purse, and placing it in her jacket. Burban then concealed the item under her jacket, passed all points of sale, before exiting the store with the two other individuals without payment. Alexandre then reviewed the CCTV footage and notified Mall Security of the theft. Mall Security Officer Davis then observed the individuals enter Louis Vuitton. I arrived at Burberry and confirmed the theft via CCTV and responded to Louis Vuitton where Ofc Kelly had Burban stopped outside of the store. Ofc Ford also had...</p>

the male companion, later identified as Jonathan Williams, stopped just before the exit out of the mall. I was immediately able to identify the purse that Burban had stolen still clutched in her hand as she was stopped. I then immediately placed Burban under arrest for shoplifting at this time. Burban also admitted to have stolen several perfume bottles from Sephora just previously, which was confirm by the loss prevention of the store via CCTV. As this conversation was happening, the manager of Louis Vuitton, Chris Davis, exited the store and informed us that Burban had concealed a purse on her person prior to our contact. Officer Ford placed Williams under arrest at this time (see Ofc Ford's Supplemental report for further details).

After a search of Williams' person, a set of keys was found, and he admitted to have driven to the mall. I then spoke with him and gained consent to search his vehicle to locate any further merchandise, yielding negative results. Burban was then transported in V2 to headquarters to be processed. Vehicle was searched pre and post transport. Ofc Seebohm responded to all three locations, where he was able to complete a voluntary witness statement for the thefts and get receipts for all the merchandise that was taken.

Both Williams and Burban were then ran for any wants or holds with Williams showing negative results. Burban had a NCIC warrant out of Camden for shoplifting (NIC/W831613145) along with two seperate ACS warrants from Lawrence Twp and Cherry Hill. A hit confirmation was sent to Camden County and Gail Watkins responded but refused pick up at this time.

Burban was charged with three counts of 2C:20-11B(2) and one count of 2C:20-11F. Burban was charged on warrant #: 0712-W-2023-000081 and transported to the custody of Essex County Correctional Facility. Williams was charged with one count of 2C:20-7A . Williams was charged on summons #: 0712-S-2023-000080 with a court date of 05/04/23 at 9:00am and released on his own recognizance.
