Call Summary

See this officer's case report regarding both Ana and Elizabeth being arrested after they engaged in a physical altercation at the Runaway Rapids Waterpark. Upon arrival the two parties were already separated, and Ana was standing on the sidewalk outside of the park. I spoke with multiple witnesses who stated the female identified as Elizabeth approached Ana and began "swinging on her" while Elizabeth was holding a baby in her arms. During the altercation both parties sustained minor injuries. Ana presented with pain and redness below her right eye, and Elizabeth presented with an abrasion, associated with swelling and pain on one of her fingers. Both parties refused medical attention at this time. Both parties were placed under arrest and transported to the KPD HQTS where they were processed.

Elizabeth Ortiz Degado was charged with 2C:12-1A(1) on 1321-S-2024-118. Ana Espinal was charged with 2C:12-1A(1) on 1321-S-2024-120. Both parties were later released, and both provided a Keansburg Municipal Court date of 06/20/2024 at 0830hrs.

It should be noted that while speaking with Elizabeth, she showed me red marks that were on both of her children. Her daughter, [REDACTED] presented with a [REDACTED]. Her son, [REDACTED] Lt. Angerami requested KEMS for the children, but they were cancelled prior to arrival as per Elizabeth's discretion. It is unclear how the children obtained the [REDACTED] on them. I contacted AP Christopher Ammon regarding any charges that should be implemented due to the children being placed at risk, but he advised due to the lack of specific information at this time to refrain from charging either female with child endangerment.
