Narrative

On Sunday, 05/26/2024 @ 1902hrs. patrols were dispatched to 297 Lakeside Ave. for terrorist threats, caller stated subject threatened her with hedge clippers. While en route, dispatch updated that the caller is now stating the accused struck the caller with a tree branch. Upon arrival I exited my vehicle and observed a female subject next door, later identified as Jennifer Aquino, getting my attention and advising to walk towards the back yard of #297 where the incident occurred. As I walked into the back yard of the residence I observed a stairwell that connected both the backyards of #297 and #307 leading down towards the water access of the American Water Co. Reservoir.

Ms. Aquino stated that she walked down towards the water access and observed tree branches in her way at eye level. Ms. Aquino advised she went to get loppers and returned to the tree on the path and started trimming the branches. The caller and owner of #297, Kathleen Foley, saw Ms. Aquino trimming the branches and began to get agitated because of her actions. Ms. Foley approached Ms. Aquino aggressively and started screaming not to cut the branches. Ms. Aquino disregarded what Ms. Foley said and continued to cut the branches. Both subjects at this point pulled out their cell phones and started videoing one another. Ms. Foley placed herself in front of the tree so Ms. Aquino could not continue to cut anymore branches. Both subjects were approximately five feet apart from each other and Ms. Aquino advised Ms. Foley "if you touch me we will have a problem". Ms. Foley then grabbed a branch (that was still attached to the tree) and started assaulting Ms. Aquino by showing the tree branch in her face. Ms. Aquino suffered minor lacerations to the right side of her face (see file attached). Ms. Aquino was asked if she needed EMS, she declined.

I escorted Ms. Aquino over to her side of the property at #307 and advised due to her injuries I need to take photographs of her facial lacerations. I took three pictures utilizing the "Camera" app on the departmental OIC/Rover iPhone. Ms. Aquino also sent the video footage from her cell phone with the evidence of the assault to this officer's departmental email address. (see attached for footage).

After looking at both Ms. Aquino's and Ms. Foley's cell phone footage, I placed Ms. Foley under arrest for simple assault. I told Ms. Foley to put her hands behind her back and placed handcuffs on Ms. Foley's wrists double locking the cuffs. I radioed dispatch and advised I had a female prisoner. While I was placing the cuffs on Ms. Foley I also read her Miranda Rights which she stated she understood. I escorted Ms. Foley back to my patrol car (#21) through her house and exited out the front door. I opened up the rear passenger side door and checked the backseat area and patted Ms. Foley down with the back of my hand before placing Ms. Foley in it. I then seat belted Ms. Foley in the seat and advised her I have her cell phone and that I would be bringing it back to police headquarters. Sgt. Ward radioed dispatch and requested a female officer from a surrounding town to respond out to our headquarters for a search of the prisoner. I advised dispatch my starting and ending mileage and transported Ms. Foley back to police headquarters without incident.

At police headquarters, Sgt. Ward opened up the Salley port and assisted this officers into the cell block with Ms. Foley. County dispatch stated that Marlboro PD has a female officer en route for the search. Ms. Foley sat on the prisoner bench with her right hand cuffed to the bench. Officer Carotenuto #155 arrived and escorted Ms. Foley into cell block #1 for the search, coming up with negative results. Ms. Foley was processed and released on a summons (see below) with a mandatory court date. Ms. Foley's was provided and explained a copy of her summons. Ms. Foley also received her property back (iPhone) upon exiting.

I returned to #307 Lakeside Ave for a follow-up with Ms. Aquino. I provided a copy and explained the victim notification form and advised Ms. Foley was arrested and released on a summons for the simple assault.

It should be noted that all photos were deleted from the departmental OIC/Rover iPhone upon completion of this incident report.
