Narrative

Units were dispatched to 1060 Ocean Ave "Sea Bright Wine & Spirits" for a panic Alarm. While enroute, Officers were advised by dispatch they received a call from the employee that subject(s) in a vehicle bearing NJ REG: A12SXR had stolen wine and left the store. The employee advised one subject left the store on foot and the vehicle left northbound on Ocean Ave. At this time this officer began heading northbound on Ocean Ave in search of the accused vehicle, which was checked in entirety to the Highlands Bridge. DSGT began checking the area of 1060 Ocean Ave in search for the subject who had left the area on foot. At this time dispatch advised Highlands PD has sight of the vehicle and would be attempting to stop it, which they were able to stop in the entrance to Sandy Hook.

Upon this officer and DSGT Huegel arriving at the location of the stop Highlands PD was speaking with the driver, later identified as Angie Rodriguez and a backseat passenger later identified as Misael Cejas-Diaz. This officer began to speak with Rodriguez who was asked where she was coming from, at which time she stated she was ubering and giving Cejas-Diaz to a ride to his destination. Rodriguez was questioned as to where she was coming from prior to this encounter which she stated she picked Cejas-Diaz up in Keyport, but could not provide an address. This officer then asked if she could look at her Uber app to find the location at which time she stated she was not ubering and Cejas-Diaz was a friend of a friend and was giving him a ride.

DSGT Huegel then spoke with the employee of Sea Bright Wine & Spirits, which Sgt Junquet was also on location to help with reviewing security footage of the incident. (See DSGT Huegel's supplement).

At this time Rodriguez and Cejas-Diaz were placed under arrest for shoplifting and conspiracy to commit shoplifting. Both subjects were checked for weapons/contraband with negative results. Rodriguez was then handcuffed and placed into my patrol vehicle, while Cejas-Diaz was handcuffed and placed into DSGT Huegel's vehicle. Both subjects were then transported to HQ where they were read their rights and signed the waiver card.

Dispatch was advised to contact a female officer to respond to SBHQ for a female search, which Captain Lambert responded and conducted a search of Rodriguez with negative findings.

Due to Cejas-Diaz not speaking English, a patrol officer from Red Bank was requested to respond to HQ to translate.

On 4/13/2024, I, DSgt. Richard Huegel # 145, was assigned to uniformed patrol supervisor, utilizing a fixed Body-Worn Camera (BWC) to my outer carrier. I was assigned to patrol unit 4309 (unmarked patrol unit,) when I was dispatched to 1060 Ocean Avenue for the report of a shoplifting incident.

Upon arrival on scene of ongoing traffic stop of vehicle involved (NJ REG: A12SXR), I spoke with the owner and her son regarding having photos and or video of incident in question. Ben Perrin did provide photos and video to this officer of all subjects involved. Identification was made of subjects involved and confirmed it was the party actively stopped.

Patrol placed subjects into custody and all video surveillance was taken for evidence and put into Axon.
