

ON SUNDAY, MARCH 23, 2025 AT APPROXIMATELY 0547 HRS P.O. KEENAN, P.O. CACHOLA, PO GRIFFIN AND I RESPONDED TO THE AREA OF ELMWOOD TERRACE AND MOLA BLVD ON A REPORT OF AN MVA.

UPON ARRIVAL I OBSERVED THE DRIVER, LATER IDENTIFIED AS BRIANNA MARTINEZ (DOB [REDACTED] OF 151 B MOLA BLVD IN ELMWOOD PARK NJ 07407 WALKING AROUND OUTSIDE HER VEHICLE WHICH HAD STRUCK TWO PARKED VEHICLES (APPROX. 50 FEET SOUTH OF ELMWOOD TERRACE). I EXITED MY UNIT, AT THAT TIME P.O. KEENAN (FIRST ARRIVING OFFICER) DISPATCHED BLS #448 TO THE SCENE. AFTER A SEARCH OF THE VEHICLE TO SEE IF ANYONE WAS INJURED WITH NEGATIVE RESULTS.

THE DRIVER STATED SINCE JANUARY HER VEHICLE WOULD SHUT OFF WHEN SHE TURNED ON THE HEAT. THE DRIVER WAS SHOWING VIDEOS OF HER VEHICLE SHUTTING OFF WHILE RUNNING, AND STATING ITS HONDAS FAULT. WHILE SPEAKING WITH THE DRIVER I DETECTED A STRONG ODOR OF AN ALCOHOL EMANATING FROM HER MOUTH AREA AS SHE SPOKE. I ALSO OBSERVED THE DRIVERS EYES TO BE BLOODSHOT, WATERY, AND HAVE DROOPY EYELIDS. I ASKED THE DRIVER IF SHE HAD BEEN DRINKING AND SHE STATED NO, SHE WAS TRAVELING FROM PATERSON TO GO TO HOME (151 B MOLA BLVD ELMWOOD PARK). AND KEPT STATING HER VEHICLE SHUT OFF CAUSING HER TO CRASH.

I ADVISED THE DRIVER SHE WOULD NEED TO PERFORM THE STANDARDIZED FIELD SOBRIETY TESTS. THE FOLLOWING TESTS WERE CONDUCTED ON A FLAT LEVEL SURFACE, THAT WAS FREE OF DEBRIS, AND WELL LIT.

THE FIRST TEST CONDUCTED WAS THE HORIZONTAL GAZE NYSTAGMUS, CONDUCTED BY P.O. GRIFFIN, A PRE-TEST EVALUATION REVEALED EQUAL PUPIL SIZE, EQUAL TRACKING, AND NO RESTING NYSTAGMUS. DURING THE TEST THE DRIVER DISPLAYED LACK OF SMOOTH PURSUIT IN BOTH THE LEFT AND RIGHT EYES, DISTINCT AND SUSTAINED NYSTAGMUS AT MAXIMUM DEVIATION IN BOTH THE LEFT AND RIGHT EYES, AND ON-SET OF NYSTAGMUS PRIOR TO FORTY-FIVE DEGREES IN BOTH THE LEFT AND RIGHT EYES.

THE SECOND TEST I EXPLAINED AND DEMONSTRATED WAS THE WALK AND TURN. THE DRIVER WOULD NOT LISTEN AND WAS BEING CONFRONTATIONAL AND ATTEMPTED TO COMPLETE THE WALK AND TURN ON HER OWN WALKING WELL OVER 15-20 STEPS WHICH IS MORE THEN THE REQUIRED 9 STEPS.

THE THIRD TEST I EXPLAINED SHE WOULD NEED TO COMPLETE THE ONE LEGGED STAND, THE DRIVER REFUSED AND WAS BEING LOUD AND COMBATIVE, AT THAT TIME I ADVISED HER SHE WAS BEING PLACED UNDER ARREST FOR 39:4-50 (DRIVING UNDER THE INFLUENCE). SHE WAS HANDCUFFED, SEARCHED, PLACED IN THE REAR PASSENGER COMPARTMENT OF UNIT 422 AND TRANSPORTED TO POLICE HEADQUARTERS WITHOUT INCIDENT, BY MYSELF. THE REAR PASSENGER COMPARTMENT OF UNIT 422 WAS SEARCHED PRIOR TO PLACING THE DRIVER INSIDE AND UPON REMOVING HER AT HEADQUARTERS WITH NEGATIVE RESULTS. P.O. KEENAN REMAINED ON SCENE UNTIL NUTCHIE'S TOWING ARRIVED ON SCENE AND IMPOUNDED THE VEHICLE AS PER JOHN'S LAW.

AT HEADQUARTERS THE DRIVER WAS PLACED ON THE HOLDING BAR AND I THEN READ HER THE NEW JERSEY ATTORNEY GENERAL'S STANDARD STATEMENT FOR MOTOR VEHICLE OPERATORS PURSUANT TO N.J.S.A. 39:4-50.2(e) TO WHICH THE DRIVER REFUSED. I ADVISED HER REFUSAL WOULD BE ADMISSION OF GUILT, AT THAT TIME SHE STATED I DID NOT HAVE PROOF SHE WAS DRIVING THE VEHICLE AND REFUSED A SECOND TIME. AT THAT TIME I WROTE HER 39:3-10.24 REFUSAL TO SUBMIT TO A BREATHILIZER/CHEMICAL TEST. WHILE I WAS ATTEMPTING TO READ THE LAST DRINK LOCATION REPORT AND DRINKING AND DRIVING QUESTIONNAIRE SHE WOULD NOT COOPERATE AND REFUSED TO ANSWER QUESTIONS.

I ISSUED THE FOLLOWING SUMMONSES: E25-001761 FOR 39:4-50 D.W.I., E-25-001773 FOR REFUSAL TO SUBMIT TO A BREATHILIZER/CHEMICAL TEST, E25-001770 CARELESS DRIVING NO ACCIDENT INVOLVING PERSONAL INJURY, AND E25-001771 FOR 39:4-96 RECKLESS DRIVING. ALL SUMMONSES WERE MADE RETURNABLE TO THE ELMWOOD PARK MUNICIPAL COURT.

ON 03/23/2025 AT 0805 HRS HENRY JUNIOR ORTIZ (FRIEND OF THE DRIVER) RESPONDED TO POLICE HEADQUARTERS AND AFTER READING AND SIGNING THE POTENTIAL LIABILITY WARNING FORM, TOOK CUSTODY OF THE DRIVER. BRIANNA MARTINEZ WAS SUBSEQUENTLY RELEASED R.O.R. PENDING HIS GIVEN COURT DATE OF 04/15/2025 AT 1300 HRS IN THE ELMWOOD PARK MUNICIPAL COURT.






