Narrative

On the above date and time I was on patrol in the area of SR 34 & Merchants Way. I observed a red sedan, later identified as NJ #A83PTL, fail to come to a complete stop at the stop sign at the intersection of SR 34 & Merchants Way. I followed the vehicle to 260 SR 34 (The Village Inn), where I conducted a motor vehicle stop. I observed there to be a driver and a front seat passenger in the vehicle. The vehicle pulled into a parking stall within The Village Inn.

I exited my patrol vehicle and met with the driver, who identified himself as Kenneth Lelong. I advised Kenneth of the reason for the stop and we spoke briefly about his registration and insurance cards for the vehicle. I asked Kenneth who he was traveling with and he paused as the passenger exited the vehicle and voluntarily offered information identifying herself as Kathleen Muller. I returned to my patrol vehicle to ensure the validity of Kenneth's driver license and locate pedigree information for Kathleen.

An initial search through the Spillman database (indicating prior involvements with law enforcement) revealed Kenneth to have a valid drivers license. I located a Spillman number for a subject named Amanda Johnson, who had alerts in her Spillman file as a subject to provide false information. I located a case number in Freehold Township where she provided false information to officers. I exited my patrol vehicle to speak with Kathleen further and obtain further information to identify her.

Kathleen did not have identification with her. I double checked the spelling of her first and last name, which she confirmed as Kathleen Muller. The subject provided a birthday of 10th. The subject provided an address of Morningside Avenue in Union Beach.

A search in Spillman revealed a drivers license for this subject, with a birthday of October 10th, 1975. I observed the birthdays to be different as the subject provided a birthday of October 15th, 1976. I returned to the vehicle to speak with the subject further, as I observed Amanda to have a possible NCIC warrant out for her arrest. I requested Dispatch to run Kathleen Muller and Kenneth Lelong for warrants.

I asked the subject why she was providing a different birthday than what appeared on her drivers license. She responded that she has not renewed it and went into her motel room to check if she had any identification with her name on it. While she walked into her motel room, I observed her to have a back tattoo, which I observed Amanda Johnson to have a tattoo in a similar position on her back from booking photographs from previous arrests.

I spoke with Kenneth again on the drivers side of his vehicle. Kenneth advised the name of the subject was "what she told you". I asked Kenneth where he was traveling from and he began mumbling and saying something regarding a friend and did not know. At this time, the subject who identified herself as Kathleen Muller exited the motel room and began saying she only had cash and nothing with her name on it. I asked her again why she was providing a different birthday than what appeared on her drivers license. She advised she thought she had a warrant out for her arrest. At this time, I asked her to lift up her pants so I could see if she had any tattoos. I observed red cherry's with black lettering underneath the cherry's on her right leg and "His Angel" on her left leg. It should be noted these tattoos along with the tattoo on her back matched Amanda Johnson's tattoos in her booking photographs on Spillman. I returned to my patrol vehicle and requested Ptl. Hoffman to assist.

While in my patrol vehicle I requested Dispatch run Amanda Johnson for warrants. While in my patrol vehicle, a male subject approached and began speaking with me. I advised him of the circumstances for the stop and advised I was attempting to identify the front seat passenger. It should be noted this male subject also referred to the front seat passenger as "Kathy".

Ptl. Hoffman arrived on location and was apprised of the issues I encountered with identifying the female passenger. Ptl. Hoffman and I returned to speak with the female

passenger to obtain a social security number. The female passenger advised she did not know her social security number as she had medical issues. I also asked to see the tattoo along the bottom of her back, which matched the booking photograph of the tattoo for Amanda Johnson.

Dispatch confirmed the NCIC hit, along with three ACS warrants from various towns across New Jersey for Amanda Johnson. Ptl. Hoffman and I approached the motel room and asked Amanda to step out and speak with us. Amanda was then advised of her arrest warrants. I requested she turn around and put her hands behind her back. Amanda walked away from me and sat down on the stairway leading to the second floor. Amanda stood up and I attempted to grab her arm to place her into handcuffs. Amanda pulled away from me and walked into the room. I allowed Amanda to put on a different pair of shoes.

Amanda and patrols exited the room where she tied her shoes on NJ . Amanda requested an ambulance respond, as she was not feeling well due to drug withdrawal. I advised I would have first aid respond to headquarters to treat her. Amanda walked again towards the stairway, grabbing a cigarette from the male subject seated there. Once again, I attempted to grab her arm to place her into handcuffs. She pulled away from me and walked up the stairs towards the railing.

I advised Amanda I was placing her under arrest for her active warrants. Amanda began to run up the stairs, where she climbed the railing and jumped towards the wooded area behind The Village Inn. Amanda began running into the wooded area where Ptl. Hoffman grabbed her arm. Amanda pushed Ptl. Hoffman away when he attempted to apprehend her and I performed a take down on Amanda, bringing her to the ground. I advised Amanda to stop resisting as she began to tense up and pull her arms away from me as I tried to place her into handcuffs. It should be noted during this interaction, my body worn camera fell off my vest.

While attempting to place Amanda into handcuffs, she kicked Ptl. Hoffman in the right leg while on the ground. Amanda continued to tense her arms and place them underneath her body, not allowing patrols to place her into handcuffs. Amanda kicked Ptl. Hoffman multiple times while attempting to place her under arrest. Patrols put handcuffs on her left arm and Amanda grabbed a nearby tree with her right arm and would not let go. I removed her right arm from its place on the tree where she tensed up again and placed it under her body. Eventually, Amanda was placed into handcuffs and brought to the standing position. Immediately, I requested Dispatch have an ambulance respond to headquarters to assess Amanda for any injuries she may have sustained. Ptl. Hoffman sustained a cut on his left hand and right forearm. I sustained cuts to my left arm during the interaction.

Amanda was brought to headquarters and placed in the booking room. Amanda was searched by Ptl. Molinelli with negative results. Amanda was processed per department policy and was brought to Bayshore Medical Center by first aid to be treated for drug withdrawal. Amanda had complaints of abdominal pain and was transported on the ambulance with Ptl. Hoffman. Ptl. Mason responded to Bayshore Medical Center to stand by with Amanda until her release.

Amanda was charged with two counts of aggravated assault, one count of hindering and resisting arrest. It was determined the charges would be placed on a warrant (1304W2024000024) and Amanda was transported to MCCI by Ptl. Mason and Ptl. Hoffman. Kenneth was issued a summons for 39:4-144 which was placed on the windshield of his vehicle. Nothing further at this time.
