<b>Narrative</b>											
Details of Incident (Indicate Means of Identification)											
On April 2, 2025, I was dispatched to M&T Bank, located at 62 Main Street, in reference to a report of check fraud that had just occurred. The Roseland Police Department had been notified by M&T Bank in their town regarding fraudulent activity, which had since extended to a location in Millburn. Roseland PD detectives responded to the scene and, upon receiving the update that the fraud was now occurring in Millburn, they contacted Millburn PD for assistance. Dispatch provided a vehicle description of the suspect vehicle: a 2021 gray 530i BMW bearing New Jersey registration A23UXV.											
Upon arrival at the bank, I met with Camila Estrada, a banker at M&T Bank. She reported that at approximately 1428 hours, an unknown white male with red hair, who was representing himself as "Peter M. Davis," entered the bank to cash a check and deposit the remainder into his account. The suspect was...

later identified as Erik Wells, not Peter M. Davis. The check in question was written for the amount of \$5,518.00. Wells filled out a deposit slip, requesting \$3,000.00 in cash and a deposit of \$2,518.00.

Estrada noted that Wells was able to answer all questions related to the account, including the Social Security number and address on file. However, when asked which account he wished to withdraw from, Wells appeared uncertain. Estrada then requested identification in the form of a driver's license. Wells stated that he did not have a driver's license, claiming it had been taken due to a prior DUI.

Estrada explained the bank's policy regarding the lack of proper ID and informed Wells that the requested cash would need to be ordered. The suspect left the premises but returned shortly after, inquiring about the delay in receiving the cash. Estrada once again denied the transaction, at which point Wells became upset and left the bank.

Estrada also provided a description of a passport card ID that Wells presented, which appeared to be fake. She completed a signed statement regarding the incident and mentioned that video footage could be made available at a later date.

Detectives Herrera and Wichelns arrived at the scene shortly thereafter. They contacted "Peter M. Davis" via phone and confirmed that he had not authorized the transaction, nor had he given anyone permission to access his account.

While at the bank, Officer Dalakian spotted the suspect vehicle, a gray BMW with New Jersey registration A23UXV, which was observed turning into the Short Hills Gardens apartment complex. Officer Dalakian initiated a motor vehicle stop. During the stop, stolen checks, credit cards, CDS, and passports were recovered from the vehicle, none of which belonged to the occupants. All three occupants were placed under arrest on scene and the suspect vehicle was seized for a forfeiture proceeding. The vehicle was towed to Millburn Police Department by Seton Towing.

The victims were contacted via phone and informed of the stolen items. Victim Notification Forms were subsequently completed and emailed to Kristina Burns, Jeff Hill, Nathan Nasser, Lucy Salazar, Lori Jelonnek, and Peter Davis. All CDS, stolen items, including checks, cards, and IDs, were placed into evidence.

Erik Wells, Juzan Spence, and Sherrir Rupertt were transported to the Millburn Police Department and processed in accordance with Millburn Police Standard Operating Procedures. Wells, Spence, and Rupertt were checked ATS, ACS, and NCIC. Wells had an active NCIC warrant out of Stroudsburg, PA with extradition out of New Jersey. Spence and Rupertt were negative all the way around.

All cell phones were seized for further investigation along with \$701.00 dollars found on Spence.

The arrestees were charged with the following criminal complaints.

**Juzan Spence:** Charged under Millburn Complaint Number S 0717 2025 000124 with one count of 2C:21-17.3B(1), one count of 2C:21-6C(1), one count of 2C:5-2A(2), and one count of 2C:21-17A(1).

**Erik Wells:** Charged under Millburn Complaint Number W 0712 2025 000123 with one count of 2A:160-10. Additionally, Wells was also charged under Millburn Complaint number S 0712 2025 000126 with one count of 2C:35-10A(1), one count 2C:36-2A, and one count of 2C:21-6C(1).

**Sherrir Rupertt:** Charged under Millburn Complaint Number S 0712 2025 000125 with one count of 2C:21-17.3B(1), one count of 2C:21-16, one count of 2C:5-2A(2), and one count of 2C:21-17A(1).

Erik Wells was remanded to the Essex County Correctional Facility. Juzan Spence and Sherrir Rupertt were released on their own recognizance with a CJP court date of May 6, 2025, at 0900 hours.
