Narrative

On May 8th, 2025 at approximately 2327 hours, I Patrolman Kevin Quinn #106 responded to Wawa (1413 SR 36, Hazlet NJ) for a report of an intoxicated subject. Patrolwoman LaCapria #114 was already on scene prior to my arrival. Patrolman Rucinski #95 also arrived on scene. The accused subject was identified as Stephanie Starr (hereinafter referred to as Stephanie). Stephanie appeared to be intoxicated and I could smell the odor of alcoholic beverage coming from her person. Patrolman Rucinski provided Stephanie a ride back to her residence at [REDACTED]

Once back at her residence, Stephanie refused to go inside and verbally started to berate her grandparents, along with patrols on scene. I asked Stephanie multiple times to go inside the residence and she refused. Stephanie continued to use offensive language toward patrols and her grandparents. Stephanie then walked inside the residence and began confronting her grandmother. Stephanie then walked back to the front door and attempted to pass me at a very close distance. Due to officer safety reasons, I asked Stephanie to take a step back. At that moment, Stephanie told me to back up and stated "maybe I should fucking smack you." Stephanie again relayed for a second time that she would smack me. I then placed Stephanie under arrest (handcuffed behind back) for disorderly conduct. Stephanie was searched incident to arrest by Patrolwoman LaCapria. She was then placed in the rear of marked patrol vehicle 42. Stephanie was transported to headquarters without incident.

Once at headquarters, Stephanie was secured to the booking room bench. She was photographed and processed under department policy. Stephanie was charged with the following:

1. 2C: 33-2A(1)- Disorderly Conduct (Improper Behavior/Threaten-Fight)

Stephanie's charge was placed on a summons (1339 S 2025 000113). Stephanie has a mandatory court date on May 19th, 2025 at the Hazlet Municipal Court. Stephanie was provided a copy of her summons and provided a ride back to the residence. Nothing further at this time.
