Narrative

At the above date and time, I, Ptl. Taylor, was dispatched to 816 Ocean Avenue; Rum Runner for a female in the restaurant being disorderly. Caller stated that the subject was yelling in the restaurant and is refusing to leave the establishment when requested to leave. Accused was described as a female with blonde hair, wearing a red sweater.

Upon arrival, I was met briefly with the manager/caller, [REDACTED] informing this officer, that a female needs to leave and is being disorderly. When speaking to manager, the accused started walking out of the bar area. I then started talking to the accused, later identified as Arielle Gulywasz. I then informed Gulywasz to leave the establishment and she refused to do so. I then requested her again to leave which she stated she was not going to leave. Det. Sgt. Murphy then arrived on scene and informed Gulywasz that she had to leave the premise, which she stated she was not leaving. [REDACTED], the manager informed units she was cursing in the restaurant and was not leaving when asked to. Units then escorted Gulywasz out of the restaurant area and into the parking lot.

While in the parking lot of 816 Ocean Avenue; Rum Runner, Gulywasz stated she was going to drive home, we then informed her to either call an Uber or a friend to come pick her up. She then called her friend, that was already on the premise, and her friend then got her into his vehicle. Units then waited in the parking lot until the two parties left. While waiting for them to leave, the friend stated Gulywasz does not want a ride from him and that she was going to drive her own vehicle home.

Units then requested Gulywasz to exit the vehicle. Gulywasz would not exit the vehicle, she was then guided out of her friends vehicle. She was then placed under arrest, handcuffed behind her back and double locked. I then guided Gulywasz to the rear of my vehicle and placed her in the back seat. When trying to seat belt accused in, she started to attempt to exit my patrol vehicle. Accused was then transported to HQ, without incident.
