Incident Report



On August 24th, 2025, I was assigned to marked patrol unit 502 and I was working the 1900 hours to 0700 hours tour of duty. I was on routine patrol and I was traveling west in the parking lot of Home Hardware (27 Franklin Turnpike) and I approached the exit to enter Franklin Turnpike. I observed a vehicle traveling north on Franklin Turnpike, south of my location, and about to pass by my location. The vehicle, NJ REG: U17VEC, had its headlights illuminated, however, the rear tail lamps were not activated, leaving the vehicle unlit in the rear. This is a hazard for other motorists on the roadway, as well as for the operator of NJ REG: U17VEC. Further, the operator had already activated its right directional, approximately 450 feet from the intersection of East Prospect Street. I exited Home Hardware and traveled north behind the vehicle. The vehicle then turned right onto East Prospect Street and I continued to follow the vehicle. Approximately 850 Feet from Ridge Street, NJ REG: U17VEC activated its left directional and continued to keep it activated. I activated my emergency lights and the vehicle, NJ REG: U17VEC, came to a stop on East Prospect Street near Ridge Street.

I exited my patrol unit and I approached the vehicle on the driver's side. The driver, Babita Panwala, lowered the window and I detected a strong odor of an alcoholic beverage within the vehicle. Ms. Panwala stated that she was driving to her residence on 'Waldwick', and then corrected herself and said Grove Street. I requested Ms. Panwala's license, registration, and insurance. I then identified myself and advised Ms. Panwala that I was wearing a body worn camera. Ms. Panwala stated that she had just dropped her friend off and slurred her words while saying 'Ho-Ho-Kus'. At this time I requested an additional officer respond to my location and both Officer Palmieri and Bernhard arrived on scene to assist.

I advised Ms. Panwala that I detected an odor of an alcoholic beverage inside her vehicle and she stated that her friend had been drinking and that she did not drink. Ms. Panwala called her husband at this time, despite being told not to. Ms. Panwala stated to her husband that she pulled over and 'was not drinking that much'. She further stated on her call that she drank around 1800 hours. I began sobriety tests that allowed Ms. Panwala to remain inside her vehicle. The first test was to have Ms. Panwala recite the alphabet from the letter 'd' to the letter 'p' without singing. Ms. Panwala successfully completed this test.

A 2nd test I performed is commonly referred to as a finger dexterity test. I explained that Ms. Panwala was to bring each finger to her thumb while counting aloud the number I assigned to each finger. The pointer finger as '1', middle finger as '2', ring finger as '3', and the pinky being '4'. I then demonstrated that Ms. Panwala would count '1,2,3,4' and then '4,3,2,1' while bringing the assigned finger to the thumb while counting. Ms. Panwala's first attempt was not successful. While touching the fingers in the correct order, she counted aloud incorrectly. Ms. Panwala counted '4,3,2,1' with her pointer finger being 4 instead of 1 and her pinky as 1 instead of 4. Then she counted '1,2,3,4' with her pinky now 1 instead of 4 and her pointer as 4 instead of 1. After a 2nd attempt, Ms. Panwala was able to finish the test correctly.

Next, I began the Standardized Field Sobriety Tests. I asked Ms. Panwala to exit her vehicle and she complied and stood at the rear of her vehicle. Officer Palmieri returned to my patrol unit and deactivated my emergency lights. I began the Horizontal Gaze Nystagmus Test. Ms. Panwala stated that she was currently wearing contacts. Ms. Panwala stated that she would be able to track my pen with her contacts on. Outside of the vehicle, I continued to smell the odor of an alcoholic beverage coming directly from Ms. Panwala's breath.

Incident Report

I began the Horizontal Gaze Nystagmus Test. I had Ms. Panwala get into the starting position and I explained the test to her. I began the test utilizing the tip of my pen as the stimulus. During testing, I observed Ms. Panwala to have pupils of equal size and she had equal tracking in both eyes. Ms. Panwala lacked a smooth pursuit in both her left and right eyes. Ms. Panwala exhibited nystagmus in her left eye during maximum deviation when looking to her left. Ms. Panwala would not allow her eyes to go to maximum deviation when looking right. I attempted several times and Ms. Panwala would continue to not look completely to her right during maximum deviation. Further, Ms. Panwala would continually move her head during testing, despite being told numerous times to not move her head. Ms. Panwala had distinct nystagmus prior to 45 degrees in both eyes. I did not detect vertical nystagmus in either eye. At this time, Ms. Panwala's husband arrived on scene. Officer Palmieri approached the husband, Partha Panwala, and kept him across the street on the sidewalk.

The next test that I administered was the "Walk and Turn" test. I conducted this test on the sidewalk which was flat and clear of any debris. Ms. Panwala was wearing heels and chose to perform the test barefooted. Ms. Panwala stated she had no injuries that would prevent her from performing the test. I instructed Ms. Panwala to get into the starting position for the test. At this time, I explained that this position is with her left foot on the imaginary line and with her right foot in front of her left foot, with her right heel touching her left toes. Ms. Panwala began taking steps while I explained the starting position. I attempted to again explain the starting position, and I prefaced that I was placing her in the starting position and that I did not want her to walk, but Ms. Panwala again started to take steps during instruction. Ms. Panwala then rolled her jeans up her legs, stating that her jeans would go under her foot. I again attempted to place Ms. Panwala in the starting position and she again started to take steps. I was able to get Ms. Panwala in the starting position, but she then began to be argumentative, stepped out of the starting position, and questioned why the tests were being performed.

I started the "Walk and Turn Test" over again. I instructed Ms. Panwala to get into the starting position for the test. This position is with her left foot on the imaginary line and with her right foot in front of her left foot, with her right heel touching her left toes, and with her arms down at her side. I explained and demonstrated the test to Ms. Panwala and she stated that she understood the test when asked. Ms. Panwala asked a clarifying question as to what the first step counted was and I explained that portion again. During the test, Ms. Panwala missed heel to toe, turned improperly, started too soon, and stopped while walking.

The final test that I administered was the "One Leg Stand" test. Ms. Panwala again became argumentative and questioned why another test was necessary. I then clearly demonstrated and explained the test to Ms. Panwala. While performing the test, Ms. Panwala placed her hands behind her back and did not count aloud. I reminded her to count aloud and to have her arms at her side. After completing the test I instructed Ms. Panwala to place her hands behind her back and I placed her under arrest for driving while impaired due to alcohol consumption. I then secured her in the rear of my patrol unit. After searching Ms. Panwala's vehicle for intoxicants, I released her vehicle to her husband, Partha Panwala. Mr. Panwala responded to Waldwick HQ to await the release of his wife.

Once at headquarters, Ms. Panwala was placed in Booking. I read Ms. Panwala her Miranda Rights and the

NJ Attorney General's Standard Statement. After asking if Ms. Panwala would submit samples of breath, Ms. Panwala requested I reread the penalties for refusal. I then asked again if Ms. Panwala would submit samples of her breath and Ms. Panwala gave several non answers. I read and reread the final request to provide samples after Ms. Panwala continued to not give an answer. Ms. Panwala continued to give answers 'other than yes'. I advised Ms. Panwala that her responses resulted in a refusal. The refusal was completed on the Alcotest by Officer Palmieri. Ms. Panwala admitted to drinking 2 consecutive tequila shots earlier in the evening.

Partha Panwala, Ms. Panwala's husband, was inside the lobby. Mr. Panwala completed the potential liability form and was provided with a copy. Ms. Panwala was issued her summonses and received a court date of 9/8/25 at 1700 hours at Waldwick Municipal Court. Ms. Panwala was released to her husband.
