The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was the front seat passenger in a white Lexus 4D bearing FL tag HLYA22 that was observed driving without lights. Upon traffic stop, the defendant switched seats with the driver, putting herself in the drivers seat with the engine running. The defendant exhibited indicators of impairment to include a paper bar bracelet on her right wrist, glassy eyes and a dazed appearance, the odor of an alcoholic beverage emanating from her breath, unsteadiness on her feet and admission of drinking. The defendant participated in SFSE's, which showed further indicators of impairment, and was subsequently arrested for DUI.

The defendant provided breath samples of .214 / .205 .

The defendant was ID'ed via FL DL.
