## Narrative

This incident was captured on BWC.

On September 22, 2023, I was assigned to the Monmouth County DWI Strike Force Checkpoint. This was located at 75 State Route 35 North. I was in the right lane in the parking lot and was assigned to check operators for impairment. While on duty a white Jeep bearing NJ Registration S90RBT began to slowly drive towards me. I instructed the driver to stop and requested her driver license, registration and insurance card. I immediately detected a strong odor of an alcoholic beverage emanating from her person. She handed me her driver license, registration, and an expired insurance card. She was identified as Vanessa Reiser. I observed that her eyes were bloodshot and watery and she had droopy eyelids. I asked her where she was coming from and hesitated and then stated "a friends" I asked her how much alcohol she had consumed and she stated "two drinks". I asked her to recite the Alphabet from the letter "D" to the letter "T". She stated understood the instructions. She started at the letter "E" and then mumbled at the end of the test. At this point I directed her to the side parking lot for a secondary inspection.

Once she was parked to the side parking lot I activated my body worn camera. I requested that she exit the vehicle. I confirmed that she had two drinks and asked her again where she was coming from. This time she stated she was coming from Red Bank. While standing next to her I detected a strong odor of an alcoholic beverage emanating from her person. I asked her if she was sick or injured and she denied both. She denied wearing glasses or contacts. The first test I conducted was the Horizontal Gaze Nystagmus Test. I observed equal tracking and equal pupil size in both eyes. I did not observe resting gaze nystagmus. I observed a lack of smooth pursuit in both eyes. I observed a distinct and sustained nystagmus at maximum deviation in both eyes. I observed an onset of nystagmus prior to forty five degrees in both eyes. I did not observe vertical gaze nystagmus.

Also present at this time was Sgt. Mayer from the Monmouth County Sheriffs Office. She had her body worn camera activated during this incident as well. The second test I conducted was the walk and turn test. Reiser was wearing heels so I asked if she wanted to remove them. She elected to remove them. I placed her in the starting position and told her to not to begin the test until told to do so. She began the test prior to me telling her to start. I demonstrated and explained the test to her. She asked how many steps and I confirmed nine. She began the test and missed heel to toe on all steps. When she turned around she twisted her feet around. She then missed heel to toe on all steps.

The third test I conducted was the one leg stand test. I demonstrated and explained the test to her. After I did that she asked me to explain it again. I demonstrated an explained it again and she had no questions. She began the test. She was swaying from side to side and raised her arms more than six inches from her body. She put her foot down three times and the test was stopped for her safety. She was placed in handcuffs and they were double locked. She was then searched by Sgt. Mayer. She was secured in my patrol car. I requested Field Comm create an incident and requested a tow truck. The vehicle was impounded and towed by AM/PM Towing.

I transported Reiser to headquarters without incident. While transporting her there was a strong odor of an alcoholic beverage now present in my patrol car.

At headquarters she was processed and photographed. I started the twenty minute observation period at 2249 HRS using my wrist watch. She had no foreign objects

in her mouth. I read her the NJ Standard Statement for Motor Vehicle Operators. She replied "I want to talk to my lawyer". I read her the additional statement and she replied "I would like to talk to my lawyer". A refusal was entered into the Alcotest. She was issued summonses for 39:4-50, 39:4-50.2, 39:4-96, and 39:3-29c. She was released pending a court appearance. No further action.
