Body Worn Camera Used <b>NARRATIVE</b>  On 02/11/2023 at approximately 2130 hours I, Ptl. T. Manges #53 was working patrol for the Keansburg Police Department. While on patrol, I parked my assigned patrol vehicle 2115 in the Shamrock bus station parking lot and observed a motor vehicle bearing NJ Reg D72MAP going northbound on Main Street and strike a crosswalk pedestrian sign near the Henry Hudson trail. I then observed that same motor vehicle conduct a right hand turn onto Hancock Street.  I then activated my emergency vehicle lights and conducted a motor vehicle stop. While activating my emergency vehicle lights in front of 25 Hancock St, I noticed the aforementioned vehicle attempting to park. I then approached the driver side window. The operator of the MV was observed to be a female subject and immediately began to explain that she is going through a rough time in her life and she began to cry. I then requested the operator to provide me with her license, registration,

and insurance. While the operator was attempting to locate the documents, I observed her fumbling the paperwork multiple times while attempting to give it to me. The operator was then unable to provide her driver's license after searching for several minutes and kept repeating the already searched areas. I then asked for the operator's name, she identified herself as Jennifer Parsells. While speaking with Parsells I observed an odor of an alcoholic beverage was emanating from her person. I then asked Parsells to turn off the motor vehicle and step out, same agreed to do so. I then brought her to the rear of the vehicle and continued to speak with her. I observed Parsells' eyes to be bloodshot. Parsells began to act erratic, specifically by not listening to my commands and getting irate very easily when I explained to her what was going on.

I then requested Ptl. Swartz to respond to the area to conduct a standard field sobriety test (SFST's). Ptl. Swartz then responded to the area shortly after and performed the SFTS's on Parsells. Parsells was then placed under arrest for driving under the influence in violation of 39:4-50 and placed into the rear of 2115. The aforementioned motor vehicle was towed from the scene to Across Town Towing. Once at police headquarters Parsells was escorted to the processing room where our Alcotest 9510 is located. Ptl. Swartz then began the observation period and conducted the alcotest. See Ptl. Swartz supplemental report for more information regarding Parsells.

In Car Video Available Body Worn Camera Used <b>NARRATIVE</b> <p>On Saturday February 11th 2023, at approximately 2130hrs, I Ptl. Swartz was working a special detail, specifically a driving while intoxicated enforcement patrol. While assigned to this special detail I was radioed by Sgt. Neckles to assist Ptl. T. Manges with a motor vehicle (MV) stop on Hancock St.</p> <p>I then responded to the MV stop on Hancock St. that was initiated by Ptl. T. Manges in patrol unit #2115. Upon arrival I observed a female later identified as Jennifer Parsells to be standing at the rear of the vehicle she was driving, NJ reg-D72MAP a grey 2011 Jeep Patriot. I observed Parsells to be upset as it appeared she was crying, her eyes were bloodshot and watery, and she had tears running down her face. I was then advised by Sgt. Neckles and Ptl. T. Manges that Parsells needed to be evaluated utilizing the Standardized Field Sobriety Tests (SFST's).</p> <p>I then approached Parsells and immediately detected the odor of an alcoholic beverage emanating from her person. I then asked Parsells to step away from her vehicle that she was leaning on and advised her where to stand. Parsells was swaying back and forth while she walked to the where I asked her to stand. I then advised Parsells to stand up straight while keeping her feet together and to face me while I began to give instructions on the SFST's. The SFST's that were conducted were the Horizontal Gaze Nystagmus (HGN) and the walk and turn test, results are detailed below.</p> <p><b>HGN#1</b></p> <p>I advised Parsells again to stand up straight with her feet together and her hands down at her sides while I gave her the instructions. Parsells was given the instructions and verbalized to this officer that she understood the instructions when asked, I then began conducting the test. Parsells was asked 3 times throughout the HGN test to not move her head and to follow the stimulus with her eyes only. During the HGN test Parsells swayed back and forth and was unable to stand up straight. During the test, Parsells displayed a lack of smooth pursuit in both eyes, nystagmus was present at maximum deviation in both eyes, and there was also an onset of nystagmus in both eyes prior to maximum deviation. After conducting this test, I asked Parsells if she had anything to drink tonight, she stated, "Yea, I had just one drink".</p>

I then had Parsells walk with this officer in front of patrol unit #2115, as there was more room to conduct the walk and turn test. Parsells stumbled while following this officer to the area in front of patrol unit #2115. As I began to give instructions to Parsells on the walk and turn test, I advised her to stand with her right foot in front of her left foot touching heel to toe. Parsells tried to get in this position and stumbled to her right two consecutive times. On the third time Parsells stood with her right foot in front of her left foot but it was offset and not touching heel to toe. Parsells continued to stumble back and forth, and she had to keep moving her feet to maintain her balance. She then approached me with her hands in the air and stated, "I can't do this". I then continued to give instructions to Parsells on the walk and turn and demonstrated the test. Parsells was asked if she understood the instructions and she stated, "Yes".

I then advised Parsells to begin the test, she began walking, missed heel to toe on the 6th step. Parsells stumbled and almost fell as she had to grab onto her car to regain balance. Parsells was then placed under arrest, handcuffed behind her back and placed in the rear of patrol unit #2115. Parsells was transported to Keansburg Police HQ by Ptl. T. Manges in patrol unit #2115.

Once at HQ I met with Ptl. T. Manges and Parsells. Parsells was escorted into the interview room and the observation period began, while Parsells was handcuffed behind her back. I then advised Parsells of her Miranda Rights to which she waived and agreed to answer questions by this officer. During the observation period Parsells did not have any foreign objects in her mouth, Parsells did not expectorate or vomit. While speaking to Parsells her words were becoming more slurred as she was visibly upset and crying. Parsells also repeatedly told this officer that she "peed her pants".

I then prepared the room to administer the Alcotest 9510 by removing all electronic devices from the interview room and reading Parsells the NJ Attorney's General's Statement for Motor Vehicle Operator's, to which Parsells agreed to provide samples of her breath for testing.

Upon completing the Alcotest Parsells's breath test result was reported as a 0.24% BAC, (Blood Alcohol Content). Parsells was issued MV summons 1321-E23-000286 for driving under the influence as well as various other summonses for related offenses. Parsells then called her mother
