Narrative

On 8/1/23 at approximately 1520 hours MCRR notified the Highlands Police Department of a traffic complaint that originated as a hit and run out of Fair Haven. The reporting party had followed the accused vehicle into Highlands and to the SeaStreak Ferry. MCRR advised the registration on the accused vehicle was P34CHT. I responded to the area of the SeaStreak Ferry and began to search for the vehicle. While I was entering the parking lot I observed a silver Lexus SUV exiting the lot. I observed the front license plate as it passed my patrol vehicle and positively identified the vehicle as the accused. I made a U-turn and attempted to catch up with the vehicle, which was difficult because of heavy traffic in the area. I utilized my overhead emergency lights to get positioned behind the accused vehicle. A traffic stop was then conducted at the intersection of Shore Drive and Waterwich Avenue. Sgt. O'Donnell and Capt. Roxby then arrived on scene. I made contact with the driver, John Dunigan. I requested the vehicles registration and insurance as he was being stopped because his vehicle was involved in a hit and run accident in Fair Haven. It should be noted that the vehicle had moderate damage to the passenger side in roughly the 1 o'clock position. I then asked Mr. Dunigan if he was the only person to drive the vehicle today. He responded by advising me his wife had driven the vehicle from home, to pick him up at the ferry. I observed the passenger seat to be empty and inquired about his wife's whereabouts. Mr. Dunigan stated she was laying down in the back seat. I then asked Mr. Dunigan to lower the rear window so I could speak with his wife, identified as Patricia Dunigan.

I asked Mrs. Dunigan if she recalled being involved in a hit and run accident today, to which she denied being involved in. I advised her that a witness had called her in and followed her and that I was certain I had stopped the correct vehicle. Mrs. Dunigan then stated she struck a garbage can, which would not qualify as a Motor Vehicle Accident. I then informed Mrs. Dunigan that striking property is still a Motor Vehicle Accident and that she should have remained on scene and reported it. I then explained to her that her vehicle was damaged. While speaking with Mrs. Dunigan I could detect the odor of an alcoholic beverage emanating from the vehicle. I further observed her movements to be slow and her speech to be slurred. I then advised Capt. Roxby of what I was told by both parties and he informed me that the witness observed Mrs. Dunigan exit the drivers seat and enter the rear of the vehicle.

I returned to the vehicle and asked Mrs. Dunigan to step onto the sidewalk. I began to ask her about the accident. While speaking with Dunigan I could observe her to sway back and forth and be unsteady on her feet. I could continue to detect the odor of an alcoholic beverage emanating from her person. Sgt. O'Donnell asked if Mrs. Dunigan had anything to drink since she stopped driving, to which she replied no. I asked Mrs. Dunigan how much alcohol she had consumed today and she initially denied having any. When I advised her that I could smell the odor of an alcoholic beverage emanating from her person she admitted to drinking a glass of wine around noon. I then determined that I would conduct the Standardized Field Sobriety Tests on Mrs. Dunigan.

Horizontal Gaze Nystagmus:

Sgt. O'Donnell conducted the Horizontal Gaze Nystagmus test on Mrs. Dunigan. Sgt. O'Donnell attempted this test multiple times but was unable to get an accurate result due to lack of cooperation from Mrs. Dunigan.

One-Leg Stand:

The next test was the one-legged stand test. I explained and demonstrated the test for Mrs. Dunigan. It should be noted I was interrupted multiple times while

explaining the test. Mrs. Dunigan also started the test without being told to do so. During the test I observed Mrs. Dunigan sway from side to side and front to back. I also observed Mrs. Dunigan become unsteady on her feet and I concluded the test early for safety reasons.

Walk and Turn:

For the walk and turn test I placed Mrs. Dunigan into the starting position. Mrs. Dunigan failed to remain in the starting position while I explained and demonstrated the test. This test also had to be explained multiple times. Mrs. Dunigan did not touch heel to toe on each step. She also failed to count each step aloud.

Based on my training and experience I determined that Mrs. Dunigan was under the influence of alcohol. I placed Mrs. Dunigan in double locked handcuffs in front of her person. She was then secured in the rear of my marked patrol vehicle. Once her property was retrieved from the vehicle I transported Mrs. Dunigan to Atlantic Highlands Police Headquarters for the alcotest. After a twenty minute observation period Ptl. Funk administered the test. Mrs. Dunigan's BAC was determined to be .091%. It should be noted the legal limit in the state of New Jersey is .08%. Mrs. Dunigan was then transported back to HPD headquarters where she was issued summonses for 39:4-50 and 39:4-96. Mrs. Dunigan was then released to her husband, who signed the Potential Liability form.
