try on other pairs. She then places the white Versace in her pocket/sleeve while returning another pair. She then leaves the store, passing all points of sale without paying. The total value of the sunglasses is \$345. Sunglass Hut is willing to press charges.

While speaking to Toussaint, Mall Security informed dispatch that the female (later identified as Maria Elena Lobo) was observed walking into Vineyard Vines via CCTV. P/O Jezewski and P/O Bifano responded to the store and located Lobo. After Lobo made a transaction, she was stopped. Located on her head was a white Versace sunglasses matching the stolen item from Sunglass Hut. Lobo was advised of her Miranda warnings. Lobo claimed that she forgot that she placed the sunglasses on her head. Lobo was placed in handcuffs, placed under arrest, and searched. She was then transported to Millburn Police HQ for processing.

Matron Woods responded and thoroughly searched Lobo; negative for contraband.

Maria Elena Lobo was checked NCIC, ACS, and ATS; negative for wants.

Maria Elena Lobo is charged with 2C:20-11B(2). She was provided Summons S-2023-94 with a Veterans Courthouse court date of 05/10/23 at 0900 hours. Lobo was released on her own recognisance without further incident.

The Versace sunglasses was recovered and returned to Sunglass Hut.

Toussaint completed a Millburn Police Voluntary Statement. CCTV footage will be provided at a later time.
