NARRATIVE

On January 27, 2025 I was dispatched to Syrup, 552 S. Randall Rd., in reference to a retail theft that just occurred. Tri Com advised that the suspect left the restaurant after not paying the bill. Tri Com gave the description of a F/W wearing a black jacket and a neon green sweater.

Upon arrival I was flagged down by Kane County Deputies at the Kane County Branch Court. They advised me they overheard the call and observed a suspect matching that description enter the branch court. I entered the court house and they directed me to a F/W with the matching description given.

I introduced myself and asked the female, later identified as Denna Nilles, if she was just a Syrup. Denna related yes, and was aware that she didn't pay her bill but had to go to court. I asked Denna what happened and she related the following in summary:

That on today's date prior to my arrival, Denna was dropped off by her husband at Syrup. Denna placed an order for breakfast and ate her meal. Denna then advised Syrup staff that she needed to obtain payment from her husband, who was parked outside. Denna exited the business, couldn't locate her husband, and entered the branch court.

I asked Denna if she could accompany me back to the restaurant to attempt to pay for the bill and she obliged my request.

Upon arrival I met with the General Manager, [REDACTED] who related the following in summary:

That Denna indeed entered the restaurant, placed an order for breakfast, ate most of the meal and just walked out of the business. An employee ran up to Denna outside and asked for payment for the meal but Denna related she had to go to court and her husband wasn't here to pay the bill. Denna proceeded to ignore the request from staff to pay her bill and entered the branch court.

[REDACTED] related she wanted to sign complaints if Denna was unable to pay for the meal. [REDACTED] confirmed the following was stolen:

- 1 Drip coffee, \$3.75 USC.
- 1 Butcher block omelette, \$16.50 USC.

Total monetary loss was \$20.25 USC.

While on scene [REDACTED] verbally trespassed Denna and advised she was not welcome to the restaurant indefinitely. I advised Denna the legal ramifications she could incur if she comes back to the restaurant and she advised she understood.

I had Denna attempt to contact someone to help pay for her meal but she was unsuccessful. Denna related she had no identification and no form of payment on her person.

At this time Denna was taken into custody. She was handcuffed, checked for fit, double locked and searched by me with negative results. I proceeded to transport Denna back to SCPD for booking, starting/ending mileage relayed to Tri Com.

In booking I offered Denna the opportunity to make any phone calls but she declined. Denna did not provide a reason as to why not.

Denna was charged the following:

- 1 Count retail theft, Class A Misdemeanor.

Denna was given a notice to appear and given a court date of March 27, 2025, 0900 hrs. at the Kane County Branch Court.

Denna was processed without incident.

Upon completion Denna was given all pertinent paperwork and given a courtesy ride back to the branch court.
