### NARRATIVE

On 01/31/25 at approximately 1745 hours, Officer Gaske and I, (Officer N. Garcia), responded to By Your Side, 255 38th Ave, #F, for a report of an employee who was out of control. Tri-Com Dispatch advised the employee, later identified as Jennifer G. Sanchez, DOB: [REDACTED]/92, was attacking employees and damaging property. Tri-Com advised two of Jennifer's co-workers were attempting to restrain her.

It should be noted I was in full police uniform. Additionally, By Your Side is an office that offers therapy to autistic children. There were no children present during this incident.

When I arrived, I entered suite #F and noted it was a large open space with rows of desks next to each other. I was met by the complainant, [REDACTED] at the door to suite #F. I asked [REDACTED] if she was injured, and she said "no" and refused medics. [REDACTED] directed me to the lunch room where I located Officer Gaske. Inside the lunch room was Jennifer and her co-worker, [REDACTED]. Jennifer stepped out so I could speak with her privately. Officer Gaske spoke with [REDACTED]. It was reported that Jennifer battered [REDACTED] and damaged property belonging to [REDACTED] and By Your Side. See Officer Gaske's supplemental report.

Jennifer explained the following in summary: Jennifer stated her supervisor approached her and accused her of being intoxicated. Jennifer said she denied being intoxicated and told her supervisor [REDACTED] that she was just tired. Jennifer denied being aggressive towards any of her co-workers. Jennifer denied making physical contact with her co-workers. Jennifer stated none of her co-workers physically made contact with her. Jennifer denied having any alcohol or using any drugs.

I observed Jennifer's eyes to be glassed over and she was slow/thick-tongued when speaking. I could smell alcohol emitting from the area of Jennifer's mouth when she stood in front of me and spoke with me.

Officer Gaske relayed no complaints were to be signed. [REDACTED] only wanted Jennifer to leave. Jennifer interrupted me when I was speaking with Officer Gaske and stated she was "fine". I informed Jennifer that based upon my observations of her, she was not okay to drive. I asked her to call a friend or an Uber for a ride home. Jennifer agreed and walked to the area of her desk to get her phone. I followed Jennifer and she picked up her coat, which was laying on the floor near her desk. I also noticed several items on the floor on the other side of Jennifer's desk, which I assumed were from the confrontation prior to our arrival.

Jennifer started to make a phone call when she then focused on [REDACTED] who was walking on the other side of Jennifer's desk. Jennifer started to obnoxiously clap her hands and say "Good job [REDACTED]". Jennifer walked in the direction [REDACTED] was walking, still separated by a line of desks. Jennifer continued to be loud and disruptive. Officer Gaske and I told Jennifer to exit the office and continue her call outside.

located. Several of Jennifer's co-workers brought me her personal items, which I secured in my squad car.

I informed Sgt. Schumacher I had pain shooting down my right arm from hitting my elbow. The shooting pain subsided after a couple hours and a bruise formed on my right elbow.

It was learned that By Your Side wanted to pursue charges for criminal damage to property. [REDACTED] did not want to pursue charges for Jennifer battering her.

I transported Jennifer to SCPD for arrest processing. I made contact with ASA Partida, who approved felony charges for aggravated battery to a peace officer (720 ILCS 5/12-3.05(D)(4)(I)). In addition to aggravated battery to a peace officer, Jennifer was placed through arrest processing for resisting arrest (720 ILCS 5/31-1(a)) and criminal damage to property under \$500.00 (720 ILCS 5/21-1(a)(1)).

Jennifer complained of her right wrist hurting. Sgt Schumacher called for SCFD to respond. Jennifer was checked by medics and refused medical treatment.

Jennifer was subsequently released to a male subject she called to pick her up in booking. Prior to Jennifer leaving, I provided her with all of her property and copies of the complaints against her. I provided Jennifer with a NTA and pointed out her court date of March 6, 2025 at 0900 hours at the Kane County Judicial Center in room #313.

I later spoke with Officer Gaske, who stated he took pictures of the scene and was working on securing Ring video surveillance of this incident. Officer Gaske stated the manager at By Your Side, Brittany A. Galiardo, DOB: 08/07/93, wanted to pursue charges against Jennifer for damage to a desk and wall at the business. I added those damaged items to this report.

Sgt. Schumacher provided [REDACTED] with a victims' rights packet due to getting battered by Jennifer.

This incident was captured on my BWC. I reviewed my BWC video prior to writing this report.

**\*CALL FOR SERVICE WAS CAPTURED ON RESPONDING OFFICERS DEPARTMENT ISSUED AXON BODY-WORN CAMERAS. I REVIEWED MY VIDEO PRIOR TO WRITING THIS REPORT\***

It should be noted that responding St. Charles Police Department (SCPD) officers were in marked squad cars and wearing full patrol uniforms with police badges and markings.

255 38th Avenue is a single story, multi-office building with several entrances/exits. By Your Side has one unit in the building. The separate businesses and offices have a common hallway to the main entrance/exit.

In summary:

On 01/31/2025 at 1745 hours, Tri-Com dispatched Ofc. N. Garcia and I to a disturbance at By Your Side (255 38th Avenue, Unit #F). Tri-Com relayed that an employee was attacking staff and destroying property. Tri-Com said that the employee was currently being restrained by two other employees and possibly intoxicated, which was the cause of the start of the incident.

When I arrived, I was met by the complainant/victim (identified as [REDACTED]) outside the building. [REDACTED] led me to the office area for the employees of By Your Side and pointed to the lunch room for the employees, where the problem employee named Jennifer was currently with other employees. Ofc. N. Garcia arrived and came into the office with me.

I opened up the door to the lunchroom and met with two employees (identified as [REDACTED]). [REDACTED] Jennifer appeared to be crying and I asked to speak with her outside in the office area. Jennifer ended up speaking with Ofc. N. Garcia.

[REDACTED] observed Jennifer stumble and walk into doorways multiple times today. [REDACTED] initially thought it was because Jennifer was tired, but decided to speak with her. [REDACTED] said she started the supervisor/employee confrontation around 1700 hours.

[REDACTED] Jennifer also started grabbing items and throwing them. Jennifer threw her personal belongings down (which were at her desk/workstation), causing an approximate 2"X1" hole of damage to By Your Side property (being the desk). Jennifer grabbed a decorative turtle (totaling approximately \$15.00 USC) and threw it, causing it to break. Jennifer grabbed other property off of nearby desks and threw other items (not causing damage to those items). Jennifer also slammed a door into the wall of an adjacent working area of By Your Side. The slamming of the door into the wall caused the door stop to be pushed into/embedded into the wall with an approximate 4"X3" hole.

I asked [REDACTED] if she wished to pursue charges for disorderly conduct, battery, or criminal damage to her property. [REDACTED] said she did not want any arrest or charges. [REDACTED] said she just wanted police to escort Jennifer outside. [REDACTED] said an employee investigation would be done and there would be action taken from that investigation.

I met with Ofc. N. Garcia and advised her of the complaint and request to only remove Jennifer from the business.

Ofc. N. Garcia then went to speak with Jennifer, advising her that she was being told to leave. Ofc. N. Garcia advised Jennifer that based on the complaint and her current state, she should not be operating a motor vehicle. Ofc. N. Garcia asked Jennifer to call for a ride or ridesharing service to come pick her up. Jennifer repeated, "I'm telling you, I'm okay." In the brief moment, I observed Jennifer's eyes to be glazed over and she spoke with a thick-tongued, slurred speech. Jennifer then went over to her desk area to grab her phone. I observed Jennifer stumble when walking.

Jennifer grabbed her phone and looked at [REDACTED] Jennifer then began to clap saying, "Good job [REDACTED] Good fucking job!", which was escalating and now causing a disturbance inside the office area. To avoid Jennifer

escalating further and to get the desired resolution from the complainant, Ofc. N. Garcia was attempting to lead Jennifer outside. I observed Jennifer turn around and unprovoked, without warning, batter Ofc. N. Garcia with an open hand shove via Jennifer's left arm, which caused Ofc. N. Garcia to stumble back. Ofc. N. Garcia responded by grabbing Jennifer's left arm to start to gain control. I grabbed Jennifer's right arm and she pulled her right arm away from me. I attempted to grab Jennifer's right elbow and right wrist to apply pressure/counter-pressure with Jennifer still moving her right arm and resisting efforts to be arrested. At that time, Ofc. N. Garcia responded by turning to her left and taking Jennifer to the ground. Jennifer went down and I moved around them to assist in holding/securing Jennifer's right arm to be placed in handcuffs (which Ofc. N. Garcia checked for proper fit and double-locked).

Based on the non-compliance and believed to be secured area, I asked [REDACTED] to open up a door for us to escort Jennifer outside. I assisted Jennifer to the standing position to be escorted out to Ofc. N. Garcia's squad. [REDACTED] opened up the office exit to the hallway area. Ofc. N. Garcia took Jennifer's left arm and I grasped Jennifer's right upper arm to escort her out. As we exited the door to the By Your Side office, Jennifer yelled "You fucking bitch!" and used her right leg/foot to kick [REDACTED]'s left knee.

Ofc. N. Garcia responded by pulling Jennifer to the left into a corner of the hallway area. Jennifer then kicked off the hallway wall, which shoved Ofc. N. Garcia and I back. I maintained a grasp of Jennifer's right upper arm and pulled her forward to continue walking down the hallway. As we approached the front door, [REDACTED] came around to open up the door for us and Jennifer attempted to kick [REDACTED] again in the same manner as she did before with Jennifer yelling, "YOU STUPID BITCH!". Ofc. N. Garcia responded to Jennifer's aggression and combat by driving her left shoulder down and I grabbed Jennifer's waist to give her upper body momentum downwards in a high/low takedown. Jennifer continued to yell repeatedly, "I WILL FUCK YOU UP! I WILL FUCK YOU UP!". I continued to hold down Jennifer's right upper arm and shoulder while Ofc. N. Garcia pushed down on Jennifer's upper back with her hand, pinning Jennifer's upper torso into the ground to maintain control of her.

Ofc. N. Garcia asked [REDACTED] if she got hit and [REDACTED] said she did. Jennifer responded by saying, "Yeah you did." At this time, Sgt. Schumacher arrived on scene to find us in this position. Sgt. Schumacher switched positions with Ofc. N. Garcia, so she could pull her squad car closer. Sgt. Schumacher placed downward pressure onto Jennifer's left upper arm and grabbed her left wrist. I maintained control of Jennifer's upper right arm and she attempted to knee/kick me with her right leg. I then placed my left hand on her legs to pin them down. I pinned her legs down with my left knees to control her and avoid any further battery. I told Jennifer to not kick me and I explained she is being charged with aggravated battery to a police officer. I told her not to move.

Jennifer began to sob/cry and I asked her if she was injured. Jennifer responded by saying, "You're asking me right now if I'm injured? My fucking right cuff is injured. You fucking idiot. You're a fucking idiot cop right now." Jennifer turned her hips to her left (which shifted weight) and she attempted to knee me again with her right leg. Jennifer then said, "You're a fucking idiot if you're telling me that anything is injured. Cause you are injuring my fucking right

hand."

It should be noted that throughout the whole arrest/escort, Jennifer was twisting her hands while they were in handcuffs.

Ofc. N. Garcia arrived with her marked squad car to the exit near us. I told Jennifer to stand up and she turned to her left away from me and into Sgt. Schumacher grabbing her right arm to help her up. After she was standing, I grabbed Jennifer's upper left arm to continue escorting her to Ofc. N. Garcia's squad.

During this incident, I was not injured. I later became informed that Ofc. N. Garcia's right elbow was knocked during one of the struggles with Jennifer.

I went back inside the office. I used a department issued digital camera and I took photos of the hallway, office area, and damage. I observed a Ring camera present in the office area which was photographed. I photographed the damage to the desk that Jennifer was using and wall where the door was slammed, causing the door stopper to be broken/embedded into the wall. The SD card that I used was submitted into SCPD Evidence so the files could be downloaded onto the SCPD evidence server.

[REDACTED] advised her supervisor was believed to have access to the Ring camera video. [REDACTED] provided her supervisor's information [REDACTED] I later identified her as [REDACTED] DOB: [REDACTED] I later submitted an Axon Community Request to [REDACTED] for the Ring camera video present in the office area where the damage and arrest occurred. [REDACTED] wished to pursue charges against Jennifer for the damage to By Your Side's property.

I then cleared this call for service and returned to patrol.

AGGRAVATED BATTERY/PEACE OFFICER

255 38TH AVE., #F (BY YOUR SIDE)

01/31/2025

In summary, on 01/31/2025 at approximately 1745 hours, this department was dispatched to a disturbance at 255 38th Ave., #F (By Your Side), which is an autism therapy center. Tri-Com Central Dispatch relayed an employee was attacking other staff and that the employee was possibly intoxicated.

Upon arrival, Ofc. N. Garcia and Ofc. Gaske were already on scene. An employee directed me down a common hallway in the office building, where Ofc. N. Garcia and Ofc. Gaske had the offender, Jennifer G. Sanchez, restrained on the ground. Jennifer was lying on her stomach/side. Ofc. N. Garcia was on the left side of Jennifer's person and Ofc. Gaske was on the right side of Jennifer's person. I took Ofc. N. Garcia's position as she went to bring her police vehicle closer to the nearest exit. I utilized straight arm control on Jennifer's left arm. Jennifer proceeded to attempt to knee/kick Ofc. Gaske with her right leg. Ofc. Gaske asked Jennifer if she was injured, at which time she complained that her right cuff was injured. Jennifer again attempted to knee Ofc. Gaske with her right leg. It should be noted that Jennifer was twisting her hands while her hands were handcuffed.

When Ofc. N. Garcia arrived to the exit, I assisted Jennifer in standing up by grabbing her right arm. I utilized straight arm control on Jennifer's right arm while escorting her out of the building. Jennifer was then secured in Ofc. N. Garcia's police vehicle.

After Jennifer was secured in Ofc. N. Garcia police vehicle, Ofc. N. Garcia reported to me that she was experiencing pain in her right elbow. Ofc. N. Garcia declined medical attention.

I returned to the police department, at which time I learned that Ofc. N. Garcia developed a bump/bruise on her right elbow. I took photographs of Ofc. N. Garcia's injury and entered the photographs into evidence.

I met with Jennifer in the booking room. I asked Jennifer if she was injured. Jennifer proceeded to show me a bite mark on her right wrist and said she was bit by a child at her work. I asked Jennifer if she was injured as a result of this incident. Jennifer then said she was experiencing pain in her right wrist as a result of being detained in handcuffs. I observed slight redness on the top of Jennifer's right wrist. I did not observe any other visible injuries on Jennifer's person. I requested the St. Charles Fire Department respond to evaluate Jennifer.

I took photographs of Jennifer and her right wrist, and entered the photographs into evidence.

Rescue personnel from the St. Charles Fire Department arrived to evaluate Jennifer. Rescue personnel asked Jennifer about her wrist. Jennifer explained to rescue personnel that she injured her wrist in grade school and that it has been "wonky" ever since. Jennifer also explained to rescue personnel that a child bit her wrist. Jennifer did not mention anything to rescue personnel about this incident or pain in her wrist due to being detained in handcuffs. Rescue personnel evaluated Jennifer and Jennifer declined transport to the hospital.

A portion of this incident was captured on my body-worn camera. I review body-worn camera video prior to writing this report.

I did not take any further action related to this case.
