NARRATIVE FOR PATROLMAN MAEVE COSGROVE

Ref: 25-495-AR

On 01/07/2025, at approximately 1419, officers were dispatched to Laurel Avenue and Commons Way for a motor vehicle accident. Upon arrival, I activated my BWC and retrieved identification, vehicle registration, and vehicle insurance from the two drivers involved. One of the subjects provided me with a Brazilian Passport and stated she had a provisional New Jersey license. The subject was identified as Sara R. Da Silva. After providing dispatch with her name and date of birth, dispatch found a suspended drivers license out of Pennsylvania and a New Jersey license for identification only. Dispatch advised Da Silva had an active ATS Warrant from Avon-By-The-Sea Municipal Court in the amount of \$777.00 for Failure to Appear (Warrant #ABS 26836).

Da Silva was taken into custody, placed in handcuffs using the double locking feature, searched, and seated in the rear of my patrol vehicle. Da Silva was transported to headquarters where she was processed. My patrol vehicle was checked before and after transport for weapons and contraband with negative result. Contact with Avon-By-The-Sea police department was made and they advised they would accept \$50.00 opposed to the full cash bail. Da Silva provided \$50.00 and was released with a future court date of 01/14/2025 at 0900 hours through Avon-By-The-Sea Municipal Court.
