This email is in response to your Open Public Records Act (OPRA) request dated 11/17/25 in which you seek access to body-worn camera (BWC) footage from ARREST OF HADEER SHARAF.

Pursuant to N.J.S.A. 47:1A-5(c) a special service charge is warranted for the retrieval, review, and necessary redaction of body-worn camera footage when compliance with the request involves "an extraordinary expenditure of time and effort to accommodate the request."

The estimated cost to process your request is: \$250.00
