Narrative

On 5/31/24 at approximately 1755 hours HPD received a call for an intoxicated subject driving from Ralph Street to the area of 300 Bay Avenue, Driftwood Liquors, in a red Ford Thunderbird. Upon arrival to the area of Driftwood Sgt. O'Donnell and I observed a female subject, later identified as Julie Kulak-Rodgers, exiting a red Ford Thunderbird, which was parked in front of Driftwood Liquors. Sgt. O'Donnell and I made contact with Rodgers, who was visibly unsteady on her feet. We advised Rodgers of why we were making contact with her and asked if she had been drinking today. Rodgers was very forth-coming and advised she had been drinking since about 11:00 AM and probably consumed 8-12 ounces of alcohol today. While speaking with Rodgers I could detect the odor of an alcoholic beverage emanating from her person. I asked Rodgers if she would be willing to participate in Standardized Field Sobriety Tests to determine if she was safe to be driving. Rodgers agreed to participate in the SFST's at this time.

The first test that was conducted with Rodgers was the Horizontal Gaze Nystagmus test. The HGN test was administered by Sgt. O'Donnell. During this test I observed Rodgers to sway from side to side as she stood in front of Sgt. O'Donnell. Upon completion of the test Sgt. O'Donnell advised he observed six out of six clues of impairment.

The next test I conducted was the Alphabet. Rodgers advised she knew the English Alphabet in its entirety and was instructed to recite the same, without singing the common ABC Song. During the test I could observe slurring in her words and at times she would repeat letters.

The final test conducted was the Finger Dexterity Test. I explained and demonstrated the test in front of Rodgers. Rodgers indicated she understood my instructions, however she began the test without being told to do so. During the test I observed Rodgers to have slow movement in her hands and I could continue to observe her to sway from side to side.

Upon completion of the testing, using my training and experience, I determined that Rodgers was under the influence of alcohol and advised her she was being placed under arrest for Driving While Intoxicated. I assisted Rodgers to my patrol vehicle, where she was secured in the rear prisoner compartment. Rodgers was handcuffed in front of her person with double-locked handcuffs and seat-belted. I then transported Rodgers back to HPD headquarters for processing. During transport I observed a strong odor of an alcoholic beverage fill the interior of my patrol vehicle. Once back at HPD headquarters Rodgers was read her Miranda Warning, which she indicated in writing that she would be willing to speak with me, as well as the New Jersey Attorney Generals Standard Statement for Motor Vehicle Operators. Rodgers indicated she would participate in the Chemical Breathe Test and a 20 minute observation period was conducted. After the observation period Sgt. O'Donnell administered the Chemical Breathe Test. Rodgers' BAC was calculated to be a .123%, it should be noted that the legal limit in the State of New Jersey is .08%. A sober party responded to sign the potential liability form and Rodgers was released with a pending court date of 6/18/24 at 3:00 pm at the Highlands Municipal Court. Rodgers was issued summonses for Driving While Intoxicated and Reckless Driving.
