Narrative

On 05/11/2023 at 15:39 hours, I was traveling north on Ocean Blvd in the Borough of Highlands. I observed a gold 4-door vehicle bearing New Jersey registration D26RWJ make a left-hand turn into the rear parking of Quick Chek. As the vehicle made a left hand turn the operator failed to utilize it's turn signal. The vehicle then drove through the rear parking lot and made a right-hand turn onto State Route 36 north. I activated my emergency light system to conduct a motor vehicle stop.

I activated my body worn camera and approached the vehicle from the driver side. I asked the female operator for her documents. The female provided with me with a valid New Jersey driver license [REDACTED] which identified the driver as Michelle Markowitz. Also in the vehicle were the rear seat passenger Gregory Decher and front seat passenger Valerie Papalia. It should be noted that I am familiar with Papalia and know her as a narcotic user.

I asked Markowitz to step out of the vehicle so that I could speak to her. Once out of the vehicle I asked her where she was coming from and she indicated that she was in town seeing her friend Dennis Plaia. It should be noted that Plaia is a known narcotics dealer and user. At this time, I asked Markowitz if she would give me consent to search her vehicle which she denied. While speaking to Markowitz I observed a [REDACTED] on the floor board in the rear of the vehicle. I asked Markowitz what the pill was. At this time, she obtained the pill from the rear floor and indicated that it said [REDACTED] on it. Through my training and experience I know that [REDACTED] At this time, I placed the pill on the rear of the trunk for the time being.

I conducted a search of the vehicle and didn't locate any narcotics or contraband in the vehicle. The Monmouth County Radio room advised me that Papalia has an outstanding NCIC warrant out of the Monmouth County Prosecutors Office as well as an ACS warrant out of Atlantic Highlands for \$503.00. At this time, I advised Papalia she was being placed under arrest and placed her hands behind her back without incident. Search incident to arrest located in Papalia's right pocket to her pants was a clear burnt glass pipe with chore boy in it. Glass pipe in this manor is commonly used to ingest crack cocaine or other narcotics. Papalia was placed in the rear of patrol vehicle 1706 for transport to headquarters.

Markowitz was released from the scene with a summons for failure to signal turn. It should be noted that the pill located in the vehicle was later found to be [REDACTED] which Markowitz indicated it was.

Once back at headquarters, Papalia was processed and transported to the Monmouth County Correctional Institute by the Monmouth County Sheriffs Office.
