## Narrative

On 10/01/23 at approximately 0113 hrs, I was traveling North on State Hwy Rt 36 when I observed a grey Nissan fail to maintain its lane in the area of State Rt 36 N and Orchard Blvd. It was at this time that I activated my overhead lights and attempted to stop the vehicle. The vehicle, NJ: A92PAU came to a stop in the area of State Rt 36 N and Beaman Blvd.

At this time I activated my Body Worn Camera and approached the vehicle. Once at the vehicle, I made contact with the owner/operator who was later identified as Stephanie Revet. Revet provided me with her license but stated that she could not find her registration or insurance. She then attempted to hand me a passport to which I advised her that I did not need at this time. During this interaction I smelled the odor of an alcoholic beverage emanating from the vehicle and Revet was the only person in the vehicle. I observed her hand movements to be slow and she fumbled through her belongings looking for her documents. It was at this time that I asked Revet if she had consumed any alcoholic beverages to which she replied that she had. I then asked her to step out of the vehicle so that I could run her through some tests to see if she was able to continue driving to which she agreed.

I asked Revet to stand behind her vehicle and await further instruction. As Revet exited her vehicle she staggered and swayed. Once at the rear of her vehicle I had her stand with her feet together so that I could conduct the first Standard Field Sobriety Test (SFST) with her. While she was standing still, she had an approximate 2 inch sway from front to back and side to side.

The first SFST I conducted with her was Horizontal Gaze Nystagmus (HGN). While conducting the test, I had to stop and explain it multiple times and she did not follow my instructions which did not allow me to accurately conduct the test. During this time I continued to smell the strong odor of an alcoholic beverage emanating from her person.

The second SFST I conducted with her was the Walk and Turn (WAT). I explained the test to her and demonstrated it for her. After the instructional phase I then asked her to perform the test. Revet conducted the test but did not walk heel to toe on any of her steps as instructed and did not take the proper number of steps on her first set of 9 steps or her second set of 9 steps. She also raised her arms for balance during the duration of the test.

The third SFST I conducted with Revet was the One Leg Stand (OLS). After the instructional phase I advised Revet that she was free to conduct the test when she was ready. While attempting to conduct the test she was unable to lift her foot off of the ground for longer than two seconds.

After the third SFST I asked her what her highest level of education was and she stated "high school". I then asked her if she could recite the English Alphabet slowly without singing to which she stated that she could. Revet was unable to recite the alphabet after multiple attempts.

Based on her performance of the SFST's and my observations of her driving, it was clear that Revet was exhibiting the signs of an individual who was under the influence of alcohol. It was at this time that I placed Revet under arrest for Driving While Intoxicated and double locked her handcuffs prior to placing her in the rear of my patrol car for transport back to headquarters. Once she was seatbelted in, Patrolman Braswell and I searched her vehicle for evidence of intoxicants to which we found two half empty bottles of tequila under her seat and on the back seat of her vehicle. Revet was transported back to headquarters

for processing.

Once back at headquarters, Revet was read her Miranda Rights to which she stated she understood them and that she would speak to me at this time. She was then read the Attorney General Standard Statement for Motor Vehicle Operators which states that she was required to supply samples of her breath for testing to which she stated "Yes". Revet provided two samples of her breath for testing which showed that she had a BAC% of 0.14%. Revet stated that she had taken 5 shots of tequila at her friends house that evening and that they had not gone out to a commercial establishment to drink.

Revet was issued summonses and given a court date in Highlands Municipal Court. Revet was able to contact a sober driver to come pick her up as per John's Law and was advised of how to retrieve her vehicle the next day. Nothing further at this time.
