**Narrative**

On July 3rd, 2024 at approximately 0036 hours, I Ptl. Vamos #117, Ptl. Turner #110, and Ptl. Poulos #120 responded to the area of State Highway 36 and Middle Road for a female subject, Stephanie Starr, who was on her way back to [REDACTED] to demand her belongings back following a domestic incident. (Ref 24HZ15278 for further information.) It should also be noted, Stephanie called the non-emergency line numerous times yelling at the dispatchers after being told she cannot go back to the residence where the domestic incident took place. (Ref 24HZ15281 and 24HZ15286 for further.)

Upon arrival, Ptl. Turner #110 was speaking with Stephanie where she was demanding that officers leave her alone and let her walk so she can "chill". While Stephanie was walking away across the highway, she was yelling "suck my cock" along with other obscenities and making inappropriate hand gestures. While Stephanie was acting out, there were pedestrians and vehicles in the immediate area. At this time, I drove across the highway and stopped Stephanie once again.

I advised Stephanie to turn around and place her hands behind her back where handcuffs were placed, double locked on her wrists. I also advised Stephanie she was being arrested for disorderly conduct. At this time, I escorted Stephanie to the rear of marked unit #59 where she was placed and secured in the backseat without incident. I then transported Stephanie to headquarters where she was escorted to the booking room and secured to the booking room bench utilizing a single, double locked handcuff.

Once secured, further processing was completed. Stephanie was charged with 2C:33-2B, which was placed on Summons # 1339 S 2024 000188. After processing, I transported Stephanie back to her residence of [REDACTED] where she advised she would stay for the night.

The complaint and suicide evaluation form were attached to this report.
