ARREST DESCRIPTION

Traffic stop operator was revealed to have two ATS warrants.

On Tuesday, October 3rd, 2023, at approximately 2040 hours I was on patrol in marked patrol unit 1807 traveling northbound on State Highway 35. I observed a black GMC SUV, bearing New Jersey registration [REDACTED] traveling in front of my vehicle. The vehicle swerved to the right and the two passenger side tires crossed over the white dotted line into the right lane of traffic. I activated Body Worn Camera # 29 initiated a motor vehicle stop in the Hazlet Movie Theater parking lot. I approached the vehicle from the passenger's side and made contact with the operator, Danielle Elia. Elia was found to have two active ATS warrants, Warrant #E22 8385 out of Union Township for \$750.00, Warrant # S503129 out of Holmdel for \$550.00. Police dispatch confirmed both warrants were active and Elia was placed in handcuffs utilizing the double locking mechanism. Elia's vehicle was parked and secured in the Chick-Fil-A parking lot. Elia was transported to police headquarters and processed. Elia was released on her own recognizance from both jurisdictions and set to appear in Holmdel Municipal Court on October 4th, 2023. An email with the Bail Recognizance form was emailed to the Holmdel Municipal Court clerk. The bail recognizance form was faxed to Union Township with the signed form advising Elia of her new court date on October, 18, 2023. Police dispatch executed both warrants. Nothing further.
